"State public health officials have reviewed the press statement issued by the CDC regarding isolation and quarantine and look forward to reviewing the CDC's complete guidance once published. Once official guidance is available, the State will be able to determine how best to implement these changes in New Hampshire for the general public and in settings such as healthcare, residential facilities and schools. At this time, residents should continue to follow NH's current isolation guidance and quarantine guidance. Changes to the State's guidance will be based on the CDC's full recommendations, and will be updated on https://www.covid19.nh.gov/ and in a Health Alert Network message to healthcare providers."



We received notice yesterday that we were not selected for funding for the DOJ School Violence Prevention Grant. Gary and I reviewed the list of successful applicants last night and they did not award any grants to NH, VT, or RI. Maine received one and Mass received three. We also noticed that almost every grant (if not all of them) were awarded to school districts.

I will be reaching out to their office to request a copy of our reviewers's scores with comments to determine what our areas of weakness were. This will help us if we decide to apply for the FY'23 funding (if they release this) in the spring. It could be as simple as the District needs to be the primary applicant and the LPD the subrecipient, which is the reverse of our current application. Or it could simply be that the successful applicants had greater needs than Laconia (larger communities, higher rates of school violence, demographic diversity, etc.).

Anyways, I'm definitely bummed about this, but it happens...it's just been a while. I look forward to our continued partnership and am certain there will be other funding opportunities that we find success with.






