On October 4, 2012 at approximately 1234 hours I responded to the intersection of Factory Street and Main Street for the report of an incident or road rage. As I was approaching the intersection I noted that there was an unusually heavy amount of traffic waiting for the traffic signal during this time of day. I then observed a large tractor trailer with it's hazards on making a delivery on the right side of the road. As I arrived on scene, I observed a Jeep Cherokee stopped diagonally in front of the tractor trailer blocking the tractor trailer from moving forward as well as the middle lane of the three lane roadway. There was no operator within the Cherokee and it appeared as though the Cherokee was illegally parked and unmanned.

As I exited my cruiser I observed a security guard for the Bank of America point towards an individual standing on the side of road. I briefly spoke with the security guard and he stated that the man was the operator of the Jeep, and that there had been some sort of argument, but that he had not seen anything just heard the disturbance. I then made contact with a male who identified himself as Steven Bolton (DOB:). I asked Bolton if he was the operator of the blue Jeep Cherokee. Bolton stated he was and when I asked him why it was parked in the middle of the road he stated that he wanted to leave it where it was when this incident had occurred. Bolton then stated that a man in a red shirt with grey hair had threatened and assaulted him, and that he would like this man immediatly arrested. At that time I advised him that the position of the vehicles were noted and that he now needed to park his vehicle so that it was not blocking traffic. To this Bolton asked me where I would like him to park it as there was no parking on either side of the street. I instructed Bolton to park it in front of the already parked tractor trailer. Bolton then asked me if I was authorizing this illegal parking and I advised him that for the time being parking the vehicle in front of the tractor trailer that was already blocking a lane of traffic was better then blocking two lanes as he was already doing. Bolton the responded to his vehicle and moved it.

While Bolton was making his way to his vehicle, I made contact with R M (DOB:) who was the male that Bolton was identifying as having assaulted him. I asked M what had happened this morning. Merritt explained that he is a contractor that has been renovating a nearby building. Today he was receiving a delivery, and that the delivery was such that the vehicle would not be able to make the delivery in the back parking lot. M explained that the tractor trailer arrived and temporarily parked on the side of the road as far out of the way as possible. M explained that it was either park the vehicle on Factory Street or block Main Street so he chose the lesser of two evils. Merritt stated he even went out into the road when the vehicle was there to instruct traffic to go around in an attempt to alleviate traffic concerns. M stated that everything was fine until a blue Jeep Cherokee approached. M stated that an older gentleman [later identified as Bolton] was speaking on a cell phone as he approached was not paying attention and must not have realized that a delivery was occurring. Finally M stated that the Cherokee whipped around the trailer at a high rate of speed. As the Jeep was pulling around the tractor trailer, the driver, identified as Brian Craig (DOB:), needed to pull the trailer a short distance forward to readjust the angle of the tailgate. M stated he tried to explain this to Bolton but that he must not have seen him. So as Bolton went to pull back into the far right hand lane the truck moved forward and almost struck the Jeep. Craig stated that he had no idea that Bolton was there until the last minute and was able to initiate an emergency stop in time to avoid a collision.

After this near miss occurred M stated that Bolton rolled his window and began to yell and swear at him. M stated he responded in kind and also began to swear and yell at Bolton. At this time Bolton exited his vehicle and M stated he and Craig realized that this had gone too far and began to attempt to calm Bolton down. M stated that there was no calming him down and that when M approached him to request he get back in his vehicle, Bolton all of a sudden stated that he [M] assaulted him and that he was going to get him

arrested. M stated he never touched Bolton and that as soon as Bolton stated he had been assaulted and he was contacting the Police, M went back to his delivery and paid no attention to Bolton.

At this time Bolton had returned and I spoke to him about what had happened. Bolton was very angry, and stated that he had been driving down Factory Street when all of a sudden a tractor trailer had almost struck him as he was changing lanes. Bolton stated that the driver began to yell and swear at him, and then another male [later identified as M] approached his vehicle. Bolton stated he exited his vehicle to speak with M , M placed his hand on Bolton chest, pushed him backwards and advised him to get back in his vehicle or else he [M] would kick his ass. Bolton then proceeded to inform me that he was a lawyer as well as a former Alderman of the City of Nashua and he would like the male arrested immediatly. I advised Bolton I was still investigating this incident. As I was speaking with Bolton, Officer Adamson stated that he had found an independent third party witness to this incident.

I then made contact with Michael Olje (DOB:). I asked Olje if he had witnessed the entire incident and he stated that he had. Olje stated he was standing on the northwest corner of the intersection of Factory Street and Main Street waiting for the crosswalk signal so he would walk southerly on Main Street. While he was waiting he observed blue Jeep pull around the tractor trailer truck at a high rate of speed. The tractor trailer moved forward and the Jeep attempted to pull in front of it. At this time there were several horns honking and a lot of commotion. At that time the operator of the Jeep began to yell and swear at the driver and subsequently exited his Jeep while leaving it in the middle of the road. At that time Olje stated that a man in a red shirt [M] approached him and asked him to get back in his car. As Olje watched he stated the operator of the Jeep [Bolton] continued to yell and scream and that M eventually just left him there. I asked Olje if there had been any contact between the two, or if there had been any threats of contact through hand motions or body language. Olje was adamant that there was absolutely no contact, and that the person who initiated the entire problem had been the operator of the Jeep. I asked Olje if he could identify the two separate men and Olje identified Bolton as the operator of the Jeep, and M the other male involved with the red shirt. I then asked Olje if he had ever seen or met either man and he stated he had no idea who they were. I thanked Olje and released him at this time.

At that time I was approached by Bolton who informed me that he was due in court because he was a lawyer and that he could not stay. I advised Bolton that he was free to go as I had already obtained his statement. At this time Bolton left the area.

Based on the statements of all the parties involved, as well as the third-party independent witness who did not know either person, at this time there is insufficient probable cause to charge M with simple assault and there is also insufficient probable cause at this time to charge Bolton with false report to law enforcement. This report is being completed to document this incident and record the facts and statements associated with it.

Also present during this meeting was Detective Captain Timothy Hefferan, Detective Lieutenant Wayne MacDonald. Mr. Teeboom had come into the Department to report an incident of Criminal Threatening that had occurred on Monday, June 12, 2000 between 8:00 PM and 8:30 PM in the Aldermanic Chambers of City Hall.</p> <p>Mr. Teeboom informed those present that he was attending a meeting of the Board of Alderman on Monday evening (June 12, 2000), and was seated in the front row of the audience gallery. He stated that he was sitting beside a friend of his, Mr. Malcolm (Mike) Lowe, and was discussing the resolution being presented by Alderman Steve Bolton regarding the appropriation of funds from an account that had been set aside for school use. Mr. Teeboom stated that the resolution was to acquire monies from this account to fund the new rectangular stadium for the Nashua Senior High School. Mr. Teeboom stated that he was speaking loudly about his opinion of the legality of appropriating said monies, indicating that he felt that the resolution was illegal. He felt that he was speaking loud enough for Alderman Bolton to hear what he was saying, though he was unsure if it was his intent for Alderman Bolton to hear him. Alderman Bolton is reported to be the sponsor of this resolution.</p> <p>Mr. Teeboom stated that Alderman Bolton had apparently overheard his conversation and got up from his seat and approached him as he was seated in the audience gallery. He was obviously upset—according to Mr. Teeboom—and began stating that the resolution was not illegal. Further, it is alleged that Alderman Bolton was shaking his finger in the face of Mr. Teeboom. Mr. Teeboom stated that he did not appreciate this behavior and instructed Alderman Bolton to "Get your finger out of my face". In fact, according to Mr. Teeboom, Alderman Kevin Gage had gotten up from his seat during this heated exchange, and placed himself between he and Alderman Bolton.

Mr. Teeboom stated that at one point, as Alderman Gage was mediating this exchange, he made the comment, "If you're going to hit me, maybe we should take this outside". Mr. Teeboom stated that this was a reactionary comment that he was agitated and was trying to diffuse. Further, he stated that if Alderman Bolton had taken him up on this challenge that he would have gone outside with him, but he did not follow up on it.

When asked what his initial reaction to this perceived threat was, Mr. Teeboom stated that he put his hands up in front of his face to protect himself. It should be noted that Mr. Teeboom placed both hands in front of his face, making a fist with both of his hands. Mr. Teeboom stated that at no time did he touch Alderman Bolton. He did not swipe at his hand, and to his recollection, he was still sitting down when this occurred. Mr. Teeboom stated further that, "if Kevin Gage was not there, he would have hit me".

Mr. Teeboom concluded by stating that he feels that this conduct is unacceptable for a public official. He felt that he was placed in imminent danger of a physical assault, and wishes prosecution for this offense. This concluded our initial interview with Mr. Teeboom. Investigation to continue.

STATEMENT TO POLICE

Criminal Threatening Complaint against Steve Bolton

I. Background

On Monday 12 June at approximately 7:00 pm I attended a school board meeting in the city auditorium that was, coincidentally, televised. During the public comment period I spoke about a Resolution R-00-98 that was on the Agenda of the Board of Aldermen to be introduced the following day, Tuesday ~~12~~¹³ June. This resolution is sponsored by Alderman-at-Large Steve Bolton.

This resolution proposes to transfer \$3.99 million from the School Capital Reserve Fund (established to pay for construction and improvements of school buildings) to pay in cash for the acquisition of land and construction of a "rectangular stadium" on this land.

This stadium has been a subject of hot debate in Nashua for weeks, and only two weeks ago (23 May) a compromise had been reached by the Board of Aldermen to acquire land and built this field with the proceeds from a municipal bond. Thus, my inquiry from the School Board was whether anyone knew of this redirection of school funds to the rectangular stadium. None of the school board members nor the school department's business manager, Mark Conrad, knew of this proposed resolution.

About 7:45 pm I went to the Aldermanic chamber to witness a meeting of the Budget Review Committee of the Board of Aldermen, engaged in its review^{of} the annual city budget for FY01.

A 15-minute recess was called by the Chairman, Mr. Fred Britton, around 8:30pm. I then related to Mike Lowe (a member of the Nashua Planning Board) my opinion on Resolution R-00-98.

I voiced to Mike that, in my opinion, this proposal was a redirection of money from the purpose for which this Capital Reserve Fund had been originally established, and therefore an illegal resolution. That is because a change in the purpose of a Capital Reserve Fund can only be established with a 3/4 vote of the Board of Aldermen, following a public hearing (see RSA 34:11).

III. The Incident

I was sitting on the front bench, right row seats, near the center isle. Mike Lowe was standing next to me, on my left. Directly in front of me is the semi-circle of Aldermen benches. I noted Steve Bolton talking to someone near the first bench on my left, possibly Kathy Hersh who had been sitting in that seat during the meeting. He stood about 20 feet away from me.

Apparently I voiced my opinion loud enough so that Steve Bolton overheard it, and I may have looked at him while I was talking with Mike, for next he walks up to me, to stand directly facing me. I remained seated.

I said to him, in effect, "Bolton, my friend, this resolution you sponsored is not legal. It changes the purpose of the School Capital Reserve Fund." Steve says to me, in a loud voice, "don't tell me what is illegal." I replied, "well, I'll drop the "friend" but the resolution is not legal".

Steve then points his index finger within a fraction of an inch away from my nose, and says, "***Do not tell me what is legal,***" with his face red and eyes bulging.

I then said, still sitting, "get your fingers out of my face!"

Next, I see Bolton's hand draw back and draw into a fist. I braced for a hit, and raised my hands and arms in front of my face.

At that instant, Alderman Kervin Gage physically pushed himself between Bolton and myself, facing me, with his hands outstretched. I think he touched Bolton, pushing him back, but I am not certain of that.

I was quite agitated by Bolton's threat and mentioned to Bolton that we could take this outside, but he did not take me up on that, and I was, frankly, not all that interested either.

I am absolutely convinced that Bolton would have attempted to hit me if Kevin Gage had not intervened. Mike Lowe who observed these events at close range expressed this same opinion to me shortly thereafter.

Steve Bolton has been acting very erratically, by reports, shouting and threatening people over a period of months. He harassed John Coughlin, the Mayor's assistant, into eventually resigning. John Coughlin reported erratic behavior on the part of Steve Bolton. Mayor Streeter made public a message left on the answering machine where very insulting remarks were made about Mr. Coughlin.

Bolton has made derogatory remarks about me, for example on the radio (protected as political free speech) but this is the first instance I am aware he has made an actual physical threat. As a latest example, in the Saturday 17 June weekly "Inside Nashua" column the incident is briefly mentioned. The article quotes Steve Bolton calling me "hateful, lying and deceitful."

IV. Follow-up

The next afternoon (13 June) after discussing the incident with my wife I decided to call Nashua Police Chief Clifton Largy. I gave him a brief synopsis. Chief Largy suggested I see Captain Hefferin the following day and file a formal complaint.

That evening I addressed the Board of Aldermen during its public comment period and mentioned, in my opinion, the illegal transfer of funds mentioned above. Mr. Bolton remarked during his remarks that he did not know "he had to check with Fred Teeboom or Paula Johnson to introduce a resolution." No mention was made of the incident.

On Thursday approximately 4:00 pm I filed my verbal complaint with Captain Hefferin, Det. Lt. Wayne MacDonald and Det. Sgt. Don Campbell in the Nashua Police Headquarters. I agreed to return on Saturday 17 June to make a formal tape recorded statement.

V. Others Informed

I told Corene Bruce of the incident the following day (14 June), but said I was not sure yet what I would do about it.


Later that day (14 June) I informed Mayor Bernie Streeter privately of my formal complaint with the police department.

VI. Conclusions

Mr. Bolton intentionally threatened me with physical harm. I am convinced Mr. Bolton needs to be charged with intentional physical threatening, if these charges are verified. I do not wish him incarcerated or disbarred, but arrangement needs to be worked out to

place him out of harm's way, or at least force him to modify his increasingly threatening and hostile behavior patterns. I consider Mr. Bolton at this point to be an "out-of-control lose canon."



He immediately stated that he was aware of the incident and provided the following:

That he was at a budget meeting of the Aldermanic committee speaking with Mr. Teeboom. He was standing to the left of Mr. Teeboom, who was seated. He stated that Mr. Teeboom was chastising Alderman Bolton on the illegality of a resolution that Alderman Bolton was sponsoring, and that Alderman Bolton took umbrage to the allegation. Alderman Bolton advanced, with his finger extended, and came within one inch of Mr. Teeboom's eye. Mr. Teeboom put his hands up, at which time Alderman Bolton made a fist, and started to take a swing at Mr. Teeboom. Alderman Gage, who had stepped between the two, interrupted this. "I was in fear of Alderman Bolton striking Mr. Teeboom", Mr. Lowe stated, "I was for sure that Bolton was going to hit Teeboom". Mr. Lowe stated that Mr. Teeboom was seated throughout this encounter. "I think he was scared out of his wits", he stated.

Mr. Lowe concluded by saying, "if roles were reversed I'd be telling you the same thing".

I informed Mr. Lowe that I would need to take a formal statement from him regarding this incident. He indicated that he would comply with my request and an appointment was set for Tuesday, June 20th, at approximately 11:30 AM.

This concluded my conversation with Mr. Lowe.



On listed date and time I met with Alderman Kevin Gage pursuant to a scheduled interview. During the course of this interview I had asked Alderman Gage to describe his observations of the confrontation between Alderman Bolton and Mr. Teeboom. Alderman Gage related the following:

"Steve and I were chatting—this was my first budget process", said Gage. He told me that they had been walking and had stepped to the public side of the rope. He recalled that Mr. Teeboom was sitting in the first row. "He looked at Steve", said Gage, "and picked up a piece of paper saying 'not legal my friend' ". Alderman Gage said that Steve spun around, stating, "don't tell me what's not legal" waiving his finger. He advanced on Teeboom quickly, responding to a repeated comment by Teeboom on the legality of the proposition, saying, "don't tell me what's legal and don't call me friend". At that time, as Alderman Bolton was closing on his personal space, Mr. Teeboom's hands go up, "like somebody's gonna get hit, defensively" said Gage. He said that there was contact made between the two when Teeboom brought his hands up in front of him—Teeboom's hand making contact with Bolton's finger. "Steve was so close, I don't know if his hands stayed down, Steve would have struck him with his finger", said Gage. At this point Alderman Gage stated that he got in between the two, separating them. Alderman Gage said that Bolton made the comment, "he tried to punch me". Additionally, Teeboom was saying to him that Alderman Bolton had hit him. He told me that he said to both that no one was going to hit anyone, and if this happened it would be very bad for everyone. Gage stated that in his opinion, the contact was slight and did not constitute an assault. "I would have put my hands up if you came at me the same way (referring to Bolton). I would have thought you were going to hit me," said Gage.

In speaking with Alderman Cote I informed him that I was investigating a confrontation between Alderman Steve Bolton and Mr. Fred Teeboom. Mr. Cote stated that he was present and provided me with a brief synopsis of his observations, which are as follows:

On Monday evening, June 12th, at a recess of the Budget Committee held in the Aldermanic Chambers, he recalled Fred Teeboom sitting in the front row of the spectator section. As Alderman Bolton was walking pass Mr. Teeboom, Mr. Teeboom made a comment to the effect that a resolution Alderman Bolton is making is illegal and his activities are illegal. Alderman Bolton was clearly agitated by what was said, turned, with his index finger in the air, and said something to the effect that he had no proof that it was illegal, that he had no right to say it was. Mr. Teeboom responded by saying don't point your finger at me. Alderman Bolton responded by saying don't accuse me of doing something illegal. During this exchange they were getting closer. He stated that he then observed Fred Teeboom, with closed fists, brought his arms up and pushed Steve's hand away, saying why don't we take this outside, or something to that effect. After Mr. Teeboom pushed Steve's hand away Steve repeated, 2 or 3 times, don't hit me. It was about that time that Alderman Gage stepped in between them saying that no one was going to hit anyone, or something to that effect.

Alderman Cote was then asked if he would be willing to give a formal statement, which he stated he would, and that he would be responding to the Department. This concluded my telephone conversation with Alderman Cote. A formal statement will be taken upon his arrival.

He said he moved over to support Alderman Gage, telling both to calm down.

Alderman Britton said that he recalls Mr. Teeboom seated in the front row with Alderman Bolton standing over him. He did not recall either party touching the other. "It happened so quick", said Britton, "voices getting louder to Gage stepping in". He further stated, "his voice was up and he lunged, sort of, into Mr. Teeboom's face". Alderman Gage stated that Mr. Teeboom put his hands up and they touched. "That for sure I thought Steve was going to do something he shouldn't", said Gage.

I asked Alderman Gage if, when Mr. Teeboom brought his hands up, he noticed Mr. Teeboom's hands to be fisted. He stated that he was not paying that much attention to his hands, he was trying to control the two, "but to me, it appeared to be defensive, not an attempt to strike out that I saw", said Gage. "I would have put my hands up to protect myself if that happened to me", Gage said further.

I told Alderman Gage that this concluded my follow-up questions at this time. I thanked him for his additional assistance then ended my contact with him.

On the aforementioned date and time I met with Attorney Kent Barker and Alderman Steve Bolton pursuant to a scheduled interview. Both gentlemen were signed in as visitors and escorted to the CID interview room.

At approximately 12:46 I provided Alderman Bolton with a Department Miranda Rights Form, which he read, stated he understood, initialing each line, and with his counsel present elected to waive his rights and speak with me regarding this incident. Attorney Barker witnessed this waiver. Attorney Barker stated that Bolton was here simply to provide the Department with his side of the story, and that at any time he felt the interview was going in another direction, the interview would be concluded.

Alderman Bolton stated that he is a member of the Budget Committee, and was present on the date in question. Bolton stated that the meeting had come to a point—they don't always take breaks—but there was a clear break in the meeting that lent itself to a recess. Bolton stated that he had been seated at his desk in chambers, which is on the westerly wall toward the northern portion of the room. The more southerly half—north half is the alderman seating, the southern benches are for the public. Mr. Teeboom was seated in the front row, close to the center aisle, sort of easterly half, Bolton stated.

Bolton stated that he had come out of the chambers area, walking through the rails, and walked pass Teeboom on his way to the water fountain and restrooms. "As I'm approaching the point where I would walk by him, he calls out 'hey Bolton', or something to that effect", said Bolton. According to Bolton, Teeboom was waiving a piece of paper that he (Bolton) recognized as a piece of legislation that he (Bolton) was sponsoring. "It had not been introduced as yet, it was due to be introduced on the 13th", said Bolton. Bolton stated that the legislation concerned itself with the funding of a new rectangular stadium for the High School. The funding issue addressed whether the City would pay for this construction by bond or through a separate account that had been set aside. "In a loud voice Teeboom was telling me it was illegal, what right do you have to introduce it?" said Bolton. Bolton said that he told Teeboom that he did not want to talk about it. According to Bolton, Teeboom remarked, "What kind of lawyer are you? This is illegal." Bolton said that at this point he was approximately five to six feet away from him. "I turned and pointed to at him and the paper", said Bolton, "that's enough, leave me alone." Bolton stated that Teeboom said that it was a change of

purpose. "I was pointing at the paper and him and said just drop it, I don't want to talk about it", Bolton stated. Teeboom is said to continue, stating to him "don't point your finger at me". "I said something like 'give me a break", Bolton said. Bolton stated that he stepped toward Teeboom pointing at the paper. Bolton said that at this point Teeboom with his arm, maybe a fist, slapped away his outstretched arm. "I stepped back and said 'you can't go around hitting me", said Bolton.


Bolton stated that it was at this point that Alderman Gage stepped in between them. He was said to be facing Teeboom with his back to Bolton. Bolton stated that Alderman Gage made the comment that nobody should be hitting anyone. Bolton said that Teeboom then made the comment, "do you want to take this outside?" "I said yeah sure I do", stated Bolton. Bolton said he made this comment sarcastically, and under his breath said something to the effect "that would be all I need."

I had asked Bolton if he had made a fist, which he responded by saying that he did not think that occurred. He stated that he stepped away, virtually certain that his hands were by his side, but could not say with certainty that his fists were or were not clenched.

When asked how close he was to Teeboom, Bolton stated, "As I am walking toward his general direction he starts, as I am walking by". Bolton said that at the initial point he was about five feet away from Teeboom. He stated that at some point he stepped closer to Teeboom, pointing at the paper. "I am close enough to him that he can push my hand away, probably three feet apart", said Bolton. "I was pointing more to his chest, during this time he is seated", "My outstretched arm is about three to four feet from him", said Bolton. "At no time was my finger within feet from his face", he said.

Bolton stated that at no time was it his intention to place Teeboom in fear for his safety. He stated that he was trying to illustrate his point that the legislation would save the city money. Bolton stated that his demeanor was one of annoyance and irritation, not anger or agitation.

Alderman Bolton was asked to record his statement, which he consented to. Cite transcription for further details.

At 1:09 PM on listed date I received a voice mail message from Ms. Shaw. She indicated that she was present for the confrontation and would be at home until 5:00 PM this evening. At 3:21 PM, immediately after receiving the message, I telephoned Ms. Shaw at . In speaking with her she indicated that she had been at the Board of Education meeting, held upstairs from the Alderman meeting. Mr. Teeboom was present at this meeting and had made comments during the public comment period with regards to his impression of the legality of a resolution that Alderman Bolton was sponsoring concerning the appropriation of funds from the Claremont funds to build the rectangular stadium.

Ms. Shaw stated that she had left her meeting and went to the Alderman meeting to see the wrap up of the budget session. When she entered the room she went to speak with Alderman Cote. She said she could hear Mr. Teeboom speaking loudly about the illegality of the resolution Alderman Bolton was sponsoring, which apparently got Alderman Bolton's attention. She stated that she, and Alderman Cote, was to the left of the room, Teeboom was to the right.

Ms. Shaw stated that Alderman Bolton walked up to Teeboom, refuting what he was saying, shaking his finger as he came across the room. At one point he got very close to Teeboom, bent down—as Teeboom was sitting—shaking his finger at him. He got very close to his face (Teeboom's), but did not physically contact Mr. Teeboom. She stated that she saw Mr. Teeboom make a fist, and swing Alderman Bolton's hand out of the way. She recalled Teeboom getting up from his seat as Alderman Kevin Gage separated the two.

I asked Ms. Shaw to come into the Department to provide a taped statement of her observations, which she consented to. She agreed to a meeting at 1:00 PM on Friday, June 30, 2000.

Ms. Shaw stated that she had been speaking with Alderman Cote and heard Mr. Teeboom speaking, loudly enough for her to hear, about the legality of a resolution that Alderman Bolton was introducing to the Board of Alderman. She stated that he appeared to be making these comments to no one in particular—almost that he was talking with himself—which apparently got the attention of Alderman Bolton.

She recalled Alderman Bolton walking over to Mr. Teeboom—who was seated in the first row of the audience gallery—shaking his finger, defending his resolution. She stated that he was walking at a controlled pace, and was saying something to the effect that the resolution was not illegal. He walked within one foot of Mr. Teeboom, with his finger pointed directly at Mr. Teeboom's face, in the area of his nose. Ms. Shaw demonstrated by pointing her finger at my face, and held her finger within several inches of my nose. Mr. Teeboom was reported to be seated during this exchange.

She stated that both persons were raising their voices. At one point Mr. Teeboom is said to have told Alderman Bolton to get his finger out of his face, and brought his arm up, with a closed fist, and pushed Alderman Bolton's hand away from his face. When this happened, Alderman Bolton stepped back, and both persons are reported to have adopted a fighting stance. She described it as both having closed fists, held in front of their chests, "like a boxing stance", she said. As Mr. Teeboom was adopting a fighting posture he was reported to be getting up from his seat.

She next observed Alderman Gage step between the two, stating the distance between them was so close that she believes that Alderman Gage's action caused Mr. Teeboom to sit back down. Alderman Gage had said something to the effect; No one is going to touch any one. The two were separated and the situation began to diffuse. She did not recall hearing any one say "let's take this outside" or anything to that effect. She did hear both saying that the other started it, almost childishly.

At the Budget meeting with the Aldermen last Saturday, I made some comments. One was regarding the fact that of the 29.9 new positions budgeted for, 14 are for teachers. The others are for secretaries and headmasters. It should be that more than 50% of all new hires be for new teachers. I suggest you all review the information I presented Saturday. Another more serious issue involves the \$56,500 dedicated for an alternative middle school. However, \$25,000 goes to fund reimbursement for teachers. This \$56,500 should all be spent to get the disruptive kids out of the schools and set up alternative middle schools. Why are these transfers taking place? And the most important issue... The Aldermen have a resolution before them to take \$3.99 million out of the Capital Reserve Fund set aside for the High School, and some is set aside for the Alternative Middle School. Is this for the Rectangular Stadium? I thought the Board of Aldermen just passed a bond resolution to pay for the stadium. Why are we now taking money from the school reserve fund? What happens to the trustees of that fund? This should be under lock and key for the designated purpose. Who are the trustees? Does anyone know what is happening?

Bill that would expand campaign filing requirements causing stir at City Hall

A proposal to expand campaign filing requirements in local elections continues to make waves in the aldermanic chamber.

The legislation sponsored by Alderman-at-Large Suzan Franks and Ward 4 Alderman Marc Plamondon, as sent back to committee several weeks ago so aldermen could give it more thought.

The proposal was reworked last week by aldermen on the Personnel/Administrative Affairs Committee.

The expanded requirements seeks to bring political committees under the city's umbrella when they raise and spend money on local elections.

Under current ordinances, any person or entity who spends or receives money for a campaign is required to file a report. The word "entity" is not defined, so political committees have not filed reports in recent elections.

The proposal would now define political committee as a group of two or more people formed for the purpose of influencing a candidate or ballot question during an election.

The political committees – along with candidates – would be required to file statements of receipts and expenditures, including the names and addresses of contributors, at least 10 days prior to an election and 30 days afterward. They would have to file again at the end of the year if there is any outstanding campaign debt or surplus.

Political committees would be required to register with the city clerk not later than 24 hours after receiving any contribution in excess of \$10 or before making any expenditure in excess of \$10.

Mike Lowe and Frank Henry, members of the Nashua Taxpayers Association, questioned where the city would draw the line on political committees.

committees.

For instance, would unions be required to file as a political committee if they contributed existing funds to a candidate and then made an endorsement, Lowe asked.

Alderman-at-Large David Rootovich, ristled at the added requirements for local offices, some of which are only part-time positions.

"It seems to me that if you are going to run for office, you need to hire an accountant, a lawyer and several other individuals before you even think of running," Rootovich said.

The committee referred questions to the city attorney's office and expects to discuss the ordinance again at the next Personnel/Administrative Affairs Committee.

Bad blood

Former Alderman Fred Teeboom and Alderman-at-Large Steve Bolton continued to battle this week in the aldermanic chamber.

Teeboom, president of the Nashua Taxpayers Association who recently lost a bid for the Board of Education, took several opportunities to raise questions about the legality of a piece of legislation introduced by Bolton, an lawyer.

Bolton's resolution recommends the city pay cash for the \$3.99 million stadium on land off West Hollis Street, using a portion of the state education aid funds set aside last June rather than bond the amount.

Paying for the project in cash would allow the city to get reimbursed for a portion of the project over the next five years rather than over the life of the 20-year bond, Bolton said. In turn, the state reimbursement would save taxpayers money, he said.

Teeboom doesn't think the money – set aside for school projects – should be used for any purposes other than those explicitly stated at the outset.

Teeboom – who has become a constant critic of the board on budget issues – claims Bolton wagged his finger at him and closed his fist during a brief recess of the Budget Review Committee meeting Monday night.

"As far as I'm concerned, that's a real physical threat," Teeboom said.

Bolton, not one to shy from a confrontation, called the claim ludicrous and described Teeboom as "hateful, lying and deceitful."

Ward 7 Alderman Lori Cardin and Ward 9 Alderman Scott Cote walked out of the aldermanic chamber at that same meeting when Teeboom gave a dressing down to the board regarding the budget decisions.

Bolton's measure was recommended for final passage Thursday night by the Finance Committee.

National spotlight

The city – or rather its mayor – made the national press again this past week.

But it wasn't quite as warm and fuzzy as the oft-mentioned 1997 Money magazine ranking it the best placed to live.

Our own Bernie Streeter gets mentioned in a couple of paragraphs in a six-page article in the acclaimed New Yorker magazine. The story focuses on Concord resident Theo Kamasinski, a judicial activist or a gadfly, depending on what side of the argument you fall.

Author Jeffrey Toobin profiles the colorful Kamasinski and his role in the ongoing investigation of the state's highest judges sitting on the state Supreme Court.

The same Kamasinski was part of a undercover team that rooted out police corruption in New York City and also was indicted for grand larceny and conspiracy, among a host of other charges. Kamasinski fled to Europe for years instead of facing the charges, according to Toobin.

But about our mayor.

The time is late April. The place is the Executive Council hearing to consider elevating Hillsborough County Superior Court Judge Linda Dalianis to the New Hampshire Supreme Court.

"The hearing was a rout," Toobin writes in describing the hearing, which was run by Streeter, a longtime member of the Executive Council.

Toobin has this to say about Streeter: "The chairman of the council, a veteran politician named Bernard Streeter, announced at the outset that he had a pressing appointment in Nashua, so all speakers would be limited to three minutes."

And then Toobin takes Streeter to task a few paragraphs later for participating in the appointment of Dalianis.

"By any commonly accepted standards, Streeter had an egregious

conflict of interest; if there were a formal code of ethics governing the conduct of the Executive Council, Streeter might well have been prohibited from evaluating the wife of his campaign manager."

Dalianis is married to state Rep. Griffin Dalianis, R-Nashua, who initially was going to run for the seat on the Executive Council that Streeter is giving up, but now is running for the state Senate.

As for Judge Dalianis, Toobin had this to say: "The issue wasn't Dalianis herself, who appeared to have impeccable credentials, but, rather, the silten machinery of a cozy establishment."

After a Telegraph editorial castigated him for his conflict, Streeter did not cast a vote on Dalianis' nomination. She was easily appointed the court.

Then there was this ...

Speaking of local folks making the national news, a recent round of Web surfing turned up mention of the criminal case involving Daniel Davidson – son of former Mayor Donald Davidson – and Teeboom.

Davidson is accused of sending anti-Semitic e-mails to Teeboom last winter.

The case was mentioned on a "white power" news Web site, devoted to keeping racists informed about racism.

Playing it straight

Though Streeter has taken some heat for conflict-of-interest situations involving personal friends (see Dalianis item above), a more recent incident shows that he knows how to treat his supporters impartially.

Streeter recently asked the Board of Aldermen to declare the long-defunct Bahama Beach Club building a safety hazard and order the owners to either fix it or tear it down at their own expense.

The club's former manager, Tim Madden, of Merrimack, was a major contributor to Streeter's campaign with a \$2,200 donation on June 24, 1999, campaign contribution records show.

Streeter said he did not know Madden prior to receiving the campaign contribution and that as far as he is aware is not a financial investor in the Bahama Beach Club.
